All fees for Enrichment Programs are handled separately from the regular tuition of the Day School; therefore, **separate checks** must be written for these programs. Acceptance into these programs is limited and admittance follows the priority categories as outlined in the Day School registration policy. Please note that the order in which the applications are received does not play a role in how applications are accepted.

All children should be picked up by **2:00 p.m.** following after school enrichment programs. Carpool is not held.
