ArtScope, led by IPC Day School Music Teacher and local artist Jill Marlar, is offered as an after school enrichment opportunity for children enrolled in Three-Year-Olds, Four-Year-Olds and Five-Year-Olds on **Mondays or Thursdays**. *Artscope* is a class designed to tap into the expressiveness children naturally seek through art. Each week children's book illustrators or famous artists throughout history are introduced allowing children to create similar but unique works. Examples include any one from author/illustrator Eric Carle to famous artist Henri Matisse. Students will explore a variety of mediums such as painting, drawing, collaged mixed media, clay and simple three-dimensional design. This is a class for any child who desires to learn, explore and create.
