**Purpose**

This Annual Report on Grant Usage is to be used to report on the use of IPC Foundation grants received earlier. This report is not used to apply for grants. To apply for funds in the next IPC Foundation Grant cycle, please refer to the IPC Grant Application Guidelines available on the Foundation's website ([www.ipc-usa.org/give/apply-for-ipc-foundation-grant.html](http://www.ipc-usa.org/give/apply-for-ipc-foundation-grant.html)) or by contacting the Foundation.

**Who Must Report and When**

A report is required for all grants. Reports on grants for operating support should cover the calendar year in which the grant was received. Reports on grants in support of specific projects should be submitted annually until the project is completed. Reports are due by December 31<sup>st</sup>, but may be delayed until January 31<sup>st</sup> of the next year to allow the recipient's annual report to be included. Grant recipients applying for a new grant in the year under report may choose to submit this report with the application in August rather than at year-end. Failure to submit the report will delay subsequent grants.
